1.7 Report – ICCTA Representative

Mr. Dave Maguire presented the following report:

Since our last meeting, there have not been any statewide meetings of the Trustee Association. Staff continues to monitor actions at the state level. The call for a special session has pretty much gone to the wayside as it is nearly impossible to get a super majority in session to pass any legislation during the summer months and it is the campaign season. Speaker Welch has announced four House working groups to address mental health, social media, gun control and reproductive rights.

Nothing is anticipated until the six day scheduled veto session starting November 15 after the General Election. It will be a lame duck session as the new legislature will not be sworn in until next January so anything that was pending during the last legislative session is on the table.

The ICCTA Executive Committee retreat this year is being hosted by College of DuPage August 19 & 20.at their Glenn Ellyn Campus.

ACCT has will be offering a chance to be selected for one of 25 complimentary one day board retreats facilitated by ACCT board services staff. While it is a nice offer, the selected colleges are responsible to travel accommodations and we currently have the same service available to us through ICCTA at no cost. It does not cost to apply if there is any interest by our board. I thought I would ask

- Colin gave an update on the golf outing, which kicks off with lunch at 11 a.m. Friday and • shotgun start at noon at Wee-Ma-Tuk. 27 teams have signed up to participate this year, and we're looking forward to another successful day.
- The annual Alumni Awards Reception and Athletic Hall of Fame Dinner will take place on Saturday, November 5 here at the Canton Campus. - 2.3 Institutional Planning
 - 2.3.1 Approve the appointment of Evyn Way to the position of Welding instructor, effective August 18, 2022, at an annual salary of \$43,832. This is a full-time, tenure track faculty position.

Mr. Schleich asked about two of the employee changes. President Oldfield said Eve Zimmerman was hired in 2018 and returned to the Ag field and is now working at Western Illinois Grain in Fairview. McKenna Barker went to Bushell Prairie City High School to teach Special Ed. Abby Beck has been here for a number of years, and she started in 2015 as an adjunct. Mr. Schleich said it seems like more turnovers in recent hires. Andrea Thomson said that isn't too uncommon especially if looking for positions with career growth.

Mrs. Butler recognized Dave Maguire for completion of 150 hours of Trustee Education through ICCTA. President Oldfield said we also recognized him last month and showed pictures of his presentation.
